Alternate dates for the Roundtable, that are currently under consideration, would be during the week of October 21, 2001 or October 28, 2001.

Beyond the Steering Committee members themselves, we express our sincere appreciation to the many dedicated volunteers in the U.S and Ukraine who have work tirelessly with us to assure the success of the Roundtable.

We also are deeply grateful to the Patrons of the Roundtable for their selfless and essential contributions.
